Optometry/Occupational therapy/assistive technology assessment services. Approximately 370 individuals with low vision received direct services which begins with comprehensive low-vision received from our specially trained low vision optometrists and occupational therapists. Intervention consists of training with prescribed adaptive devices, tools and techniques to enhance independence and safety. Specialized training by our occupational therapists and assistive technology specialists allows clients to manage their homes, attend school and or continue working. During home visits our occupational therapists evaluate the client's living environment for potential safety hazards. Our assistive technology specialists provide evaluation and training with hardware and software designed to assist low-vision.
